Justice D Y Chandrachud said, when BJP leader Subramanian Swamy mentioned the matter for urgent listing.

Swamy said the main appeals against the Allahabad High Court order are pending for the last seven years in the apex court.

He also said that a separate petition had earlier been filed by him seeking enforcement of his right to worship without much hassle at the site.

He said that he had been allowed by the apex court to intervene in the matter and is seeking expeditious disposal of the cases.

The Lucknow bench of Allahabad High Court had in 2010 ruled a three-way division of the disputed 2.77 acres at the disputed site in Ayodhya.
