Marin avenges India loss Beats Sindhu In Singapore; Srikanth, Praneeth In Semis

Hyderabad: Two Indian boys — Kidambi Srikanth and Sai Praneeth — stormed into the semifinals of the Singapore Open Super Series but it was curtains for PV Sindhu and the mixed doubles team of Su-neeth Reddy and Ashwini Ponnappa in Singapore City on Friday. Srikanth ousted rising Chinese youngster Shi Yu-qi in straight games 21-14, 21-16

while Praneeth registered another hard fought win against eighth seed Tanongsak Saensomboonsuk of Thailand 15-21, 21-14, 21-19. Sindhu was outplayed by Carolina Marin of Spain 11-21, 15-21.

Praneeth, who is known for shocking top stars, fought back after losing the first game to get past his higher ranked opponent. After Praneeth won the second game without breaking much sweat, Tanongsak dominated the first part of the third game. The world No.11 led the Hyderabad lad at 8-4, 12-9 and 16-13. Despite playing catchup Praneeth maintained the pressure right throughout. From 15-17, the world No.30 came up with a

four-point burst to close out Tanongsak.

"Very excited to be in the semifinal of a Super Series. I am looking forward to play well tomorrow and win the semifinal. But it will be a tough match against Lee. It can be anybody's game," said Praneeth, who will face Lee Dong Keun of Korea. Unlike Pra-

neeth, Srikanth had it easy against fifth seed Yuqi. The former China Open champion gave no chance for the Chinese youngster in the 36-minute demolition act. It was a surprising result as Yuqi, who is the reigning French Open champion and the All England finalist, was expected to ease past the Indian. But it was Sri-

kanth who routed the Chinese.

The world No.29 Indian will now face world No.26 Anthony Ginting of Indonesia in the semifinal. "Very happy to be in the semifinal and am looking forward to a great match tomorrow," Srikanth told ToI.

Earlier, Sindhu looked out of sorts against Marin. Having lost to Marin in the Olympic final, Sindhu defeated the Spaniard twice thereafter at Dubai and in New Delhi earlier this month. But on Friday, Sindhu failed to match the pace of Marin.

The Spaniard was quick off the blocks, secured early leads in both the games and hardly gave a chance for the Indian. Sindhu, who played two three-set matches in the last two days, moved heavily on the court as Marin cruised ahead.

Marin was up 11-4 in the first game even before Sindhu could warm up. Hitting hard and making the Indian move on either side of the court, Marin took the first game with a healthy lead of 21-11. It was no different in the second game as Marin opened with a 3-0 lead and was leading 11-6 by the break.

Even as Sindhu tried to get into rhythm, Marin clinched the second game at 21-15.

Pune: The Rowing Federation of India (RFI) has not selected rower **Dattu Bhokanal**, who represented India in Rio Olympics last year,



for its national camp which is currently under way in Bhopal, Madhya Pradesh.

Dattu had finished 13th in the single sculls event at the Olympic, the best ever performance by any Indian rower at the Olympics.

The Rowing Federation of India official said that the Army has boycotted national rowing championship for two consecutive years, including this year. As a result, their players are not eligible for the national camp which is organised by the RFI.

Speaking to TOI over the phone, the RFI President Rajlaxmi Singh Deo said, "We have been requesting Indian army to be a part of the championship. However, they did not pay heed to it. As a result, this year, we have decided to not select any of their rowers for national camp."

To select the rowers for Asian Championship, which is going to be held in the

month of September this year, the RFI has organised its camp.

"The Sports Ministry has specifically instructed us to select those players who have performed well in the national competition and hence there is no question of selecting Indian Army's rower. We do not understand why the army has stopped sending their players to the national competitions," said Deo.

According to Deo, if any rower is unable to participate

in national competition, he has to give a valid reason like attending exams, health issue etc to the federation in advance.

"However, in this case, the army did not inform us any of such issues of their rowers," said Deo.

When specifically asked why Bhokanal was also ignored for the camp, Deo clarified, "Dattu had performed better in Olympics. But he has to perform again in the national competitions if he wants to represent India in the future. Contrary, he did not participate and hence we did not consider him for the camp."

For the record, Bhokanal

had attended RFI's camp before the Olympics despite not playing the national meet. He continues to train with the army.

On why the Army have not released their rowers for the Asian camp, Major Sushil Jhorar, Training Officer, Army Rowing Node (ARN) at College of Military Engineering (CME), refused to comment on the matter. "Even Bhokanal can't speak to the press about this."

According to Army figures, their rowers have won 58 medals in Asian Championship and 18 medals in Asian Games till date. Since 2000, Indian army has produced 11 rowers who have represented India in the Olympics.

The RFI is not among the best-run federations in the country while Army has proven track record of sporting excellence. Still, being the custodians of the game in India, RFI can look over the shoulders of army despite their limited knowledge of the game. It has not gone down well with the latter and they have raised a slew of questions over selection methods of the RFI in the past.

In the tiff between army and RFI, the former's rowers seem to have been made scapegoats in a non-Olympic year.

Advani beats Kothari for Asian title

Chandigarh: Sixteen-time World Champion Pankaj Advani won his seventh Asian title by defeating Sourav Kothari 6-3 in an entertaining final of the Asian Billiards Championship here on Friday.

The first session saw Kothari run away with a 3-1 lead before the interval.

Advani, taking full advantage of the break, regrouped and came out all guns blazing to win the next frames on the trot to win his sixth Asian Billiards

liards and seventh overall Asian championship.

The other title being 6-red snooker which he won last year. The ace cueist left the spectators here awestruck with the sterling comeback he produced when it mattered most. Advani had gotten the better of Kothari in the group stages with a 4-0 scoreline. However, the final was a different contest.

Advani was left looking for answers to Kothari's form in the first four frames. Kothari made breaks of 68, 100 and 99 to lead by two frames vs in session one. Advani changed gears after the half hour intermission and came back to the table on a mission. **PTI**

या कालावधीत निर्मल भवन, मद्रास कॅफे (रूपाली), मद्रास हेल्थ होम (वैशाली) ही तीन हॉटेल सुरू केली. सात वर्षांची असताना वडील श्रीधर यांचे अकस्मात निधन झाले. त्या वेळी आल्याचा मुलगा जगन्नाथ हॉटेलमध्ये कामाला होता. त्यानंतर जगन्नाथ यांचा विवाह शशिकला यांची मोठी बहीण शकुंतला यांच्यासोबत झाला. त्या वेळी घरात कोणी मोठे नसल्याने जगन्नाथ यांनी हॉटेल व्यवसायाची सूत्रे घेतली. हॉटेल व्यवसायातून मिळणारा नफा आता आणि तीन बहिणींना देण्याचे त्यांनी कबूल केले. जगन्नाथ यांच्या वडिलांचे नाव बाबू नसताना त्यांनी हॉटेल व पोलिस प्रवचनांवर जे. बी. शेड्डी असा बदल केला. शशेंद्र याने हॉटेल ‘रूपाली’च्या परवान्यावर स्वतःचे नाव लिहिले. हॉटेल व्यवसायातून मिळणाऱ्या नफ्याचा त्यांनी अपहार केला,’ असे शशिकला यांनी म्हटले आहे. याबाबत जगन्नाथ शेड्डी यांच्याशी संपर्क साधण्याचा प्रयत्न केला. पण, त्यांचा फोन बंद होता.
