Summary of Proceedings of the 38th Annual General Meeting of Manaksia Limited

The 38th Annual General Meeting ("AGM") of the Members of Manaksia Limited was held on Tuesday, September 27, 2022 at 12:30 PM through Video Conferencing (VC)/Other Audio Visual Means (OAVM) in accordance with the applicable provisions of Companies Act, 2013, circulars issued by the Ministry of Corporate Affairs, Government of India and Securities and Exchange Board of India.

Dr. Kali Kumar Chaudhuri- Independent Director chaired the Meeting.

The Company Secretary of the Company informed that the Meeting was held through VC/ OAVM in compliance with the Circulars issued by the Ministry of Corporate Affairs, Government of India and Securities and Exchange Board of India.

Members attended and participated in the AGM through VC/OAVM only. For the purpose of technical compliance of provisions of Section 96(2) of the Companies Act, 2013, the place where the Company is domiciled i.e. the registered office of the Company was deemed to be the venue of the meeting.

The Meeting was attended by 123 Members through VC/OAVM.

Based on the confirmation received from the Company Secretary, the Chairperson of the Meeting informed the Members that requisite quorum was present and thereafter called the Meeting to order. The Quorum was present throughout the Meeting.



The Company Secretary introduced the Directors and Key Managerial Personnel (KMPs) and informed the Members that the registers and other documents, as statutorily required, were available for inspection on the e-voting website of National Securities Depository Limited. Dr. Kali Kumar Chaudhuri, Chairman of this Meeting and Mr. Suresh Kumar Agrawal, Managing Director of the Company addressed the Members and delivered their speech.

The Statutory Auditor and Secretarial Auditor were also present during the AGM through VC/OAVM.

The Notice convening the 38th AGM and Financial Statements were taken as read.

The Company Secretary then informed the Members that Ms. Pammy Jaiswal (Membership No. 48046 and CP No.: 18059), Partner at Vinod Kothari & Company, Practising Company Secretaries, Kolkata had been appointed by the Board as Scrutinizer. The facility of the remote e-voting for the Members was available from Friday, September 23, 2022 at 9:00 AM (IST) till Monday, September 26, 2022 at 5:00 PM (IST). E-voting facility was also provided during the Meeting to those Members who had not cast their votes through remote e-voting. It was informed that the voting window shall continue to remain open for fifteen minutes after the conclusion of AGM.

The Chairperson of the Meeting then gave opportunity to the Members who had registered themselves as Speakers to ask questions or share their views.

Upon the Members completing their submissions, Dr. Kali Kumar Chaudhuri, Chairman of the meeting and Mr. Suresh Kumar Agrawal, Managing Director furnished requisite clarifications to all the relevant queries raised by the Members.
