Dear Sir,

We have for reference the aforesaid letter(s) and in reply thereto we wish to state as under:

As we had intimated to you by our letter dated 19 August 2015, the lenders to the Company had invoked strategic debt restructuring (SDR) pursuant to the RBI Circular dated 8 June 2015. This envisaged the conversion of certain debt of the lenders into equity in terms of the aforesaid RBI Circular. (A copy of the said letter is annexed hereto as Annex "A")

By a letter of 2 December 2015, the Company confirmed that the conversion price for debt into equity would be the average of the closing price of the instrument on a recognized stock exchange during the 10 days preceding the reference date being 11 August 2015. (A copy of the said letter dated 2 December 2015 is attached as Annex "B").

A postal ballot was thereafter conducted for conversion of the lenders debt into equity and for the issue of shares to the lenders. Results of the postal ballot were provided to you by our letter dated 21 January 2016. (A copy of the said letter of 21 January 2016 is attached as Annex "C").

Subsequently, the lenders have been holding several discussions amongst themselves and with potential investors but, as far as the Company is aware, there has not been agreement reached between them.

In the circumstances and as is borne out by what is stated above, we submit that we have regularly and in compliance with applicable regulations, including Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, been providing the Exchanges details of all events, information, etc. that have a bearing on the performance of the Company.

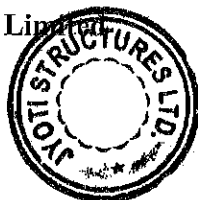
