The Company has completed on 5th September, 2015 the dispatch of postal ballot forms along with postage prepaid reply envelope to its members whose name(s) appeared on the Register of Members as on 28th August, 2015.

The E-voting commenced from 5th September, 2015 (00.00 AM) and ended on 4th October, 2015 (06.00 PM).

I have downloaded the data of E-voting after the E-voting module was disabled by the Central Depository Services India Limited on 4th October, 2015 at 06.00 PM.
