In terms of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in continuation of our letter No. HO/SD/469 dated 01.01.2016 on the captioned matter, we have to inform you further that pursuant to Regulation 7 (4) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Bank has entered into Tripartite Agreement with Previous RTA i.e. M/s MCS Share Transfer Agent Ltd., 12/1/5 Manoharpukur Road, Kolkata-700026 and New RTA M/s CB Management Services (P) Ltd., P-22, Bondel Road, Kolkata-700019. In terms of the said Tripartite Agreement, the appointment of new RTA shall commence from a cut-off date i.e. the date on which all the required documents have been handed over to the new RTA to the extent possible and new RTA will be in a position to start functioning as new RTA of the Bank. The Previous/Existing RTA i.e. M/s MCS Share Transfer Agent Ltd., 12/1/5 Manoharpukur Road, Kolkata-700026 will continue to render RTA services till completion of handing over/taking over of entire records/documents pertaining to the share registry to/by New RTA i.e. M/s CB Management Services (P) Ltd., P-22, Bondel Road, Kolkata-700019 in compliance with the SEBI guidelines and other applicable


Laws, Rules and Regulations in this regard and till shifting of NSDL/CDSL connectivity to New RTA.
