- (1) The Board of Directors of the Company at their meeting held on Wednesday, 18/05/2016, have noted the resignation submitted by Shri C Ilango, as a director and Managing Director of the Company, on his repatriation to Canara Bank w.e.f. 18/05/2016 (after office hours).

- (4) Further, as intimated in the letter dated 06/05/16 cited above, the proposal for obtaining shareholder's approval at the ensuing Annual General meeting, for raising of funds by way of issue of Non-Convertible Debentures on Private placement basis, has been approved by the Board of Directors at the meeting held on 18/05/2016.
