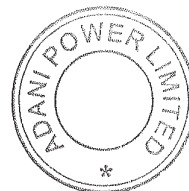
### Result of Postal Ballot

Pursuant to the Section 110 and other applicable provisions, if any, of the Companies Act, 2013 read together with Rule 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification(s) or re-enactment thereof for the time being in force) the approval of shareholders was sought by postal ballot as per details furnished in the Postal Ballot Notice dated 16<sup>th</sup> January, 2015 sent to all shareholders, on the proposal and for passing Special Resolution under Section 188 of the Companies Act, 2013 read with applicable rules under Companies (Meetings of Board and its Powers) Rules, 2014 and in terms of applicable provisions of Listing Agreement executed with the Stock Exchanges (including any amendment, modification or re-enactment thereof) and subject to such other approvals, consents, permissions and sanctions as may be required from any authority, consent of the members of the Company be and is hereby accorded to the proposed transaction of divestment of the Company's holding of 10,00,50,000 (90.91%) equity shares in Adani Transmission (India) Limited to Adani Transmission Limited (Wholly Owned Subsidiary of Adani Enterprises Limited).

Mr. Chirag Shah, a Practising Company Secretary who was appointed as the scrutinizer for conducting postal ballot process in a fair and transparent manner, submitted his report on the postal ballot.

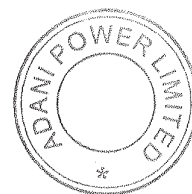

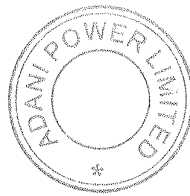
