- The Company has completed on 6th January 2014 the dispatch of Postal Ballot forms along with postage prepaid business reply envelope to its Members whose name(s) appeared on the Register of Members/ list of beneficiaries as on 2nd January 2014.
- Particulars of all the postal ballot forms received from the Members have been entered in a register separately maintained for the purpose.
- The postal ballot forms were kept under my safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.
- 4. The ballot boxes were opened on 7th February 2014 in my presence.
- The postal ballot forms were duly opened in my presence and scrutinized and the shareholding was matched/ confirmed with the Register of Members of the company/ list of beneficiaries as on 2nd January 2014.
- All postal ballot forms received up to the close of working hours on 06.02.2014, the last date and time fixed by the company for receipt of the forms, were considered for my scrutiny.
