Sub: Outcome of the Board Meeting

We wish to inform that the Board of Directors of the Company at its meeting held today (11.8.2017), has, inter alia, approved holding of 55^{th} Annual General Meeting of the Company on Wednesday the 27^{th} September 2017 at 3.00 p.m. at the Registered Office of the Company at Sakthi Nagar-638 315, Bhavani Taluk, Erode District. For this purpose, it is decided to have -

- a. Wednesday, 20th September 2017 as cut-off date for determining the members eligible for exercising voting rights.
- b. E-Voting period from Sunday, 24th September 2017 at 9.00 a.m. to Tuesday, 26th September 2017 at 5.00 p.m.
- c. Closure of Register of Members from 21.9.2017 to 27.9.2017 (both days inclusive).

The Board has recommended appointment of M/s.P.K.Nagarajan & Co (FRN: 016676S), Chartered Accountants, as Statutory Auditors of the Company by the members at the 55th Annual General Meeting (AGM) for a period of five consecutive years from the conclusion of that AGM until the conclusion of the 60th AGM of the Company, in the place of M/s.P.N.Raghavendra Rao & Co., who retire at the conclusion of the 55th AGM pursuant to Section 139 of the Companies Act, 2013.
