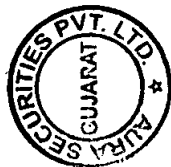
(2) we have pledged 1,20,000/- equity shares of ATUL LIMITED on 29-04-2016 in favour of Bajaj Finance Limited.
