

**Tata Steel's Q1 FY16 Key Production & Sales Figure**

**Jamshedpur, July 9, 2015:** Tata Steel Limited registered Hot Metal and Crude Steel production of 2.59 million tonnes (up by 2.4% y-o-y) and 2.35 million tonnes (up by 0.5% y-o-y) respectively for Q1 FY 16. Saleable Steel production is 2.23 million tonnes and Sales increased by 2% y-o-y to 2.14 million tonnes.
