He has advised Governments of Uttarakhand (on preparation of Eleventh Five Year Plan and Policy of Renewable and Alternate Energy Resources), and addressed Armed Forces Commanders (including Generals, Admirals, Air Marshals, and other Defence experts) on strategy.
- Professor Jain has been invited by leading Universities and Institutions across the world to lectures, keynotes
 and research recent ones being Global Corporate Governance Forum at Washington, World Bank/IFC,
 Bundesbank (Germany), Global Forum for International Investment (Paris), OECD at Paris and Copenhagen,

- In mid-1990s, taking a short break from academics, was Principal Researcher of a strategy research consulting
 firm based in Delhi (India). During this time, carried out path-breaking research on drivers of corporate
 excellence. This research was featured by Harvard Business Review (July-August 2005) as one of the ten
 most influential researches on Organizational Excellence across the world during last 25 years.
- Professor Jain was till recently Dieter Schwarz Visiting Research Chair Professor of International Business and Corporate Governance at the German Graduate School of Business and Law at Heilbronn (Germany). He was also Chairman and President of Centre for Accelerated Learning, Innovation, and Competitiveness at Germany in 2008-09.
- He is currently Professor at Indian Institute of Management Lucknow; and also holds honorary chairs as
 Adjunct Distinguished Professor of Corporate Governance and Strategy, SP Jain Center for Management,
 Singapore and Affiliated Professor of Strategy, International Business, and Corporate Governance at
 EM Strasbourg School of Business, Strasbourg (France's largest University). At both places he teaches MBA
