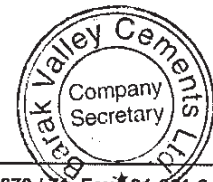

**Notes**

1. Our Company and its Promoters, Sh. Prahlad Rai Chamaria, Sh. Bijay Kumar Garodia and Sh. Santosh Kumar Bajaj, had entered into a tri-partite MOU with Lafarge India Holding Limited ("Lafarge") on 5th day of February, 2000 with a view to enter into a Joint Venture for setting up a Cement Factory in Assam. As per this MOU, Lafarge was to acquire 70% of equity shares of our Company in distinct phases. In the initial stage, the promoters delivered physical share certificates representing 2.075 lacs shares of Sh. Prahlad Rai Chamaria, 2.075 lacs shares of Sh. Santosh Kumar Bajaj and 2.07 lacs shares of Sh. Bijay Kumar Garodia, aggregating 6.22 lacs shares to Lafarge against consideration of Rs. 62.20 lacs. However, that MOU was not materialized since Lafarge had backed out of the deal and no Joint Venture Agreement was entered into between the Company and Lafarge.

As per the terms of the MOU, in case the JV is not signed and/or if the MOU is terminated, the Promoters undertook to purchase the shares from Lafarge. However, till date the aforesaid physical share certificates remain with Lafarge, though their ownership as per the records continues to be in the names of the Promoters that is why the Promoters are unable to convert their physical Shareholding into Demat mode (Sh. Prahlad Rai Chamaria - 2,07,500 Shares; Sh. Bijay Kumar Garodia - 2,07,000 shares & Sh. Santosh Kumar Bajaj - 2,07,500 shares).

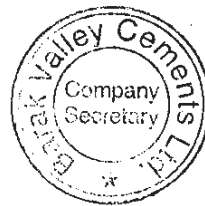

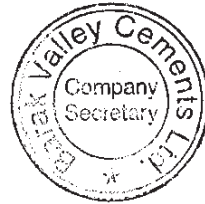

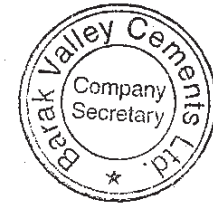
