Total issued Share Capital of the Company includes 21 Shares which are lying in the Bharti Airtel Limited - Unclaimed Suspense A/c of which voting rights are frozen till the rightful owners claim these shares pursuant to Clause 5A(II)(d) of the listing agreement and 14,96,690 shares held by Bharti Airtel Employees' Welfare Trust ("ESOP Trust") to be treated as "Non - Promoter Non - Public holding" as per Regulation 9, Chapter II of SEBI (Share Based Employee Benefits) Regulations, 2014 of which voting rights were not exercised.

The Votes casted in favour of both the resolutions are above 92% of the total votes polled and consequently the special resolutions as mentioned in the notice of the postal ballot dated October 30, 2014 have been passed with overwhelming majority.

The above results were announced by the Company on Tuesday, April 14, 2015 at the Registered Office of the Company at Bharti Crescent, 1, Nelson Mandela Road, Vasant Kunj, Phase – II, New Delhi – 110 070.
