Green field expansions: Grinding Unit at Dankuni, West Bengal

In the last 6 months the Company has commissioned the following greenfield / brownfield plants:

1. Clinker capacity of 2.0 mtpa at Aditya Cement, Rajasthan (Mar-15)
2. 2.0 mtpa Bulk Terminal on the outskirts of Pune, Maharashtra (Aug-15)
3. 1.6 mtpa Grinding unit at Jhajjar, Haryana (Sep-15)
4. **Further we are glad to inform that, the Company's has commissioned this month, its 14th Grinding unit with a capacity of 1.6 mtpa at Dankuni, in the state of West Bengal.**

With this the Company's cement capacity stands augmented to 64.7 mtpa in the country

Clinker requirement of the Dankuni Grinding will be met through Rawan Cement Works, situated in the state Chhattisgarh.

The grinding unit is strategically located at a distance of less than 50 kms from Kolkata city. Cement demand growth in the eastern region has remained higher than industry average during last 2-3 years and it continues to grow in double digits.

The Company is operating around 100% capacity utilization in the region. With commissioning of this Grinding unit, the Company has increased its cement capacity in the Eastern region to 9.8 mtpa.
