This is in continuation to our letter dated 9th April, 2015 on approval of formation of an Empowered Committee of Directors ("ECoD") to explore and evaluate various options available for the restructuring / integration of the Company, ONGC Mangalore Petrochemicals Limited ("OMPL") and their respective businesses primarily to bring about better synergy across the group, and to ensure that the businesses of these entities are operated in the most efficient and cost effective manner.

In this regard, the ECoD appointed various independent consultants, advisors, valuers, etc., from time to time, and evaluated possible options for the aforesaid restructuring / integration. ECoD has presented its findings and its recommendations to the Audit Committee of the Company today and the Audit Committee discussed these options and recommendations with the members of the ECoD and the independent consultants. The members of the Audit Committee have made certain suggestions to the independent consultants, and have requested for further time to study the proposal.
