- 1. Pursuant to the provisions of section 192A of the Companies Act, 1956 read with Companies (Passing of Resolutions by Postal Ballot) Rules, 2011, and SEBI (Delisting of Equity Shares) Regulations, 2009 ("Delisting Regulations") approval of the members of the Company was sought by a special resolution through Postal Ballot for voluntary delisting of equity shares of the Company from the Stock Exchanges in accordance with the Delisting Regulations as specified in the Postal Ballot Notice dated January 30, 2012 read with explanatory statement attached thereto.
