Trading in CIL's shares by the Designated Employees – Closure of Trading Window:-

 In view of declaration of unaudited Standalone and Consolidated financial results for the 2nd Quarter of financial year 2014-2015 by Coal India Limited Board of Directors

As per the Code of internal procedures and conduct for prevention of Insider Trading (Code) in dealing with Securities of CIL, the Company shall specify a trading period to be called "Trading Window" for trading in the Securities.
