Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results prepared in accordance with applicable accounting standards specified under the Companies Act, 1956(which are deemed to be applicable as per section133 of the Companies Act, 2013, read with rule 7 of the Companies (Accounts) Rules, 2014) and other recognized accounting practices and policies has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement including the manner in which it is to be disclosed, or that it contains any material misstatement.
- 4. Attention is invited to,
 - a. Note 3 to the statement, regarding recoverability of Rs.70512 Lakhs included under Current assets as billed/claims in respect of which the company has initiated action for recovery from the customers. The company has not made any provision for such claims in the books as the company is of the opinion that consequential financial impacts, if any, will be known only when these matters are resolved.
 - b. Note 4 to the statement regarding Rs.6876 Lakhs of invoked performance guarantees by clients due to contractual non-performance. The matter has been referred to arbitration and negotiation. Pending outcome of such proceedings, no provision has been made and the same is carried under the head loans and advances.

- c. Note 5 to the statement regarding the investment amounting to Rs. 848 Lakhs and loans and advances aggregating to Rs.3,201 Lakhs to its wholly owned subsidiaries whose net worth have been eroded and financial statements have been prepared on going concern basis for the reason stated there in.
- d. Note 6 to the statement, regarding the company continue to charge the depreciation based on Schedule XIV of the Companies Act, 1956 as the company in the process of evaluating the estimated useful lives of its tangible assets in accordance with the provisions of Schedule II of the Companies Act, 2013 which has been notified for the FY 2014-15. Pending conclusion of such evaluation and our review of the basis thereof, we are unable to comment on the appropriateness of the depreciation charge for the quarter ended December 31, 2014 in accordance with the Companies Act, 2013.
- e. Note 7 to the statement regarding the managerial remuneration where the company is in the process of obtaining the Central Government approval.

Our opinion is not qualified in respect of the above matters.
