Total 166 Members (including proxies and authorizations) attended the Annual General Meeting as per the attendance records.


The Company Secretary informed the Members that pursuant to provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company had extended the E-voting facility to the Members of the Company in respect of all the businesses to be transacted at the Annual General Meeting, through the electronic voting platform of Central Depository Services (India) Limited ('CDSL'). It was further informed that the E-voting commenced from September 23, 2014 at 9:00 A.M. and ended on September 25, 2014 at 6:30 P.M. Mr. Jayant Gupta, Practicing Company Secretary was appointed as the Scrutinizer by the Board of Directors of the Company for scrutinizing the E-voting process in fair and transparent manner. Further, the E-Voting result, basis the Scrutinizer Report dated September 26, 2014, in respect of all the businesses to be transacted at the Annual General Meeting, was also announced.

After declaration of the E-Voting Result, the Chairman ordered the Poll for all the above mentioned seven resolutions and appointed Mr. Jayant Gupta, Practicing Company Secretary as the Scrutinizer for the Poll process and requested him for an orderly conduct of the Voting by Poll. The Chairman informed that the combined result of the E-voting and Poll will be declared on September 30, 2014 at 11:00 A.M. at the Registered Office of the Company and shall be placed on the Company's website viz www.dishtv.in. Thereafter the meeting ended with a Vote of thank to the Chair.
