Re: Rating of Mahindra & Mahindra Financial Services Limited's (MMFSL) Commercial Paper Programme

India Ratings (see definition below) communicates the following rating:

'IND A1+' for MMFSL's INR 10bn commercial paper issuance.

The total commercial paper programme of MMFSL is INR 60bn.

In issuing and maintaining its ratings, India Ratings relies on factual information it receives from issuers and underwriters and from other sources India Ratings believes to be credible.
