Sub.: Put Option Exercise Form, ("Form") for Option I Secured Redeemable Non-Convertible Debentures of face value of Rs. 1,000 each, ("NCDs") issued by Shriram Transport Finance Company Limited, (the 'Company'), to the public pursuant to the Prospectus dated June 16, 2011 (the "Prospectus") and the Debenture Trust Deed dated June 28, 2011.
