Sub.: Put Option Exercise Form, ("Form") for Option I Secured Redeemable Non-Convertible Debentures of face value of Rs. 1,000 each, ("NCDs") Issued by Shriram Transport Finance Company Limited, (the "Company"), to the public pursuant to the Prospectus dated June 16, 2011 (the "Prospectus") and the Debenture Trust Deed dated June 28, 2011.

As per the terms of Prospectus dated June 16, 2011 and the Debenture Trust deed dated June 28, 2011, a Put/Call option is available with respect to Option I Secured NCDs. The Company had allotted the NCDs on July 12, 2011. Accordingly, the eligible NCD holders of Option I NCDs shall at the expiry of 48 months from the date of allotment have the right to seek early redemption of the NCDs. The eligible NCD holders may at their discretion, redeem any number of Option I Secured NCDs held by him, by exercising the Put Option during the Early Redemption Put Period.

With respect to the NCDs, our Company shall at the expiry of 48 months from the date of allotment of the NCDs, have the right to redeem the NCDs under Call Option. However, our Company is not exercising its right in this regard.
