**Sub : Outcome of HOCL Board Meeting held on 8-2-2017 - Intimation to BSE .**

This is to inform the Exchange (BSE) that, at the Board Meeting held on 8-2-2017 , the Board of Directors of Hindustan Organic Chemicals Ltd., (HOCL) have decided as under :

- 1) Board approved (in principle) the proposal of sale of 442 acres of HOCL land at Rasayani to BPCL at the rate of Rs. 1.40 Cr. Per acre subject to receipt of NOCs from the charge holders and such other approvals and approvals from the Government authorities;
- 2) The Board subject to such other approvals and approval from the Government authorities, approved the proposal of Strategic Disinvestment of [11060000 Eq. Shares of Rs.10/- each] equity shares aggregating to 56.43% in its subsidiary Co. viz. Hindustan Fluorocarbons Limited (HFL)
- 3) Accordingly, Board at the said meeting have also approved the issue of Postal Ballot Notice and Form to the Shareholders of the Company for their approval on the above stated proposals Resolutions. In this regard the detailed Postal Ballot Notice & Forms will be also submitted to the Exchange (BSE) in compliance of the LR's.
