(1) That the Official Liquidator, High Court, Madras be and is hereby appointed as the Provisional Liquidator of the respondent company, viz., Edserv Softsystems Limited.

(2) That the Provisional Liquidator appointed herein shall take charge of the assets of the said respondent Company.

(3) That the Ex-Directors of the respondent Company herein be and are hereby directed to file their statement of affairs before the Official Liquidator, High Court, Madras within a period of 21 days.

(4) That the notice of this Company Petition be affixed on the Court notice Board, and at premises of the registered office of the respondent Company.

(5) That the notice of this company petition returnable by 16/9/2013 be served on the respondent company herein and the Registrar of Companies, Madras.

(6) That the Petitioner herein be and is hereby directed to publish the Company Petition in one issue of Tamil Daily "Makkal Kural" and in one issue of English Daily "Trinity Mirror" by giving at least fourteen days clear advance notice, fixing the date of hearing as 16.9.2013.

(8) That the publication in the Tamil Nadu Government Gazette be and is hereby dispensed with.


(9) That the above matter be posted on 16.9.2013.
