- 2 The Financial results have been reviewed by Audit Committee and approved by the Board of directors in its meeting held on 08th August 2014. The above results have been reviewed by Statutory Auditors of the Company as required under Clause 41 of the Listing Agreement.
- 3 The entire operation of the Company relate to only one segment viz. Polymer based multiple products.
- Effective from 1st April 2014, the company has charged depreciation on the basis of remaining useful life of the assets as per equirement of Schedule II of the Companies Act 2013 ("the Act") or as reassessed by the Company. Consequent to this, depreciation charged for the quarter ended 30th June 2014 is higher by Rs 1.43 millions. In respect of the assets completing its useful life, an amount of Rs 0.93 million (Rs 1.37 million being WDV of assets completing its useful life and Rs 0.44 million being deferred tax reversal thereon) has been adjusted against opening balance of the retained earnings in accordance with the transitional provision provided in Note 7 (b) of the Schedule II of the Act.

We have reviewed the accompanying statement of standalone unaudited financial results of EMMBI INDUSTRIES LIMITED. (Formerly known as EMMBI POLYARNS LIMITED) (the Company) for the quarter ended 30th June, 2014 (the statement) excepts for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from the disclosures made by the Management but have neither been reviewed nor have been audited by us. The Statement has been prepared by the Company pursuant to Clause 41 of the Listing Agreement with the Stock Exchanges in India, which has been initialled by us for identification purposes. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement.

A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

We have only traced the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' in the Statement from the disclosures made by the Management and are, therefore, not expressing a review opinion thereon.
