- 1. The above results were reviewed by the Audit Committee and approved by the Board of Directors at its meeting held on 14th February, 2015 and have undergone "Limited Review" by the Statutory Auditors of the Company.
- 2. The Company has terminated its Joint Venture Agreement with Simon Holding S.L., Spain on 8th September, 2014.
- 3. Other Income for the quarter and nine months ended 31st December, 2014 is net of loss on sale of investments Rs. Nil and Rs. 72.09 lacs respectively.
- 4. Pursuant to notification of Schedule II to the Companies Act, 2013 with effect from 1st April, 2014 as further amended on 29th August, 2014 depreciation for the quarter/ nine months ended 31st December, 2014 has been provided on the basis of estimated useful lives of fixed assets as prescribed in the said Schedule as against the Written Down Value Method being followed up to 31st March, 2014. The management believes that the above change better reflects the actual useful lives of the assets. As prescribed under Accounting Standard (AS) 6 " Depreciation Accounting", the change has been made with retrospective effect and the surplus resulting from the change in the method for the period up to 31st March, 2014 amounting to Rs.359.52 lacs (net of deferred tax of Rs.157.53 lacs) has been shown as Exceptional item and credited to the Statement of Profit and Loss. As a result of the above change, the charge on account of depreciation for the quarter and nine months ended 31st December, 2014 is lower by Rs. 10.82 lacs and Rs. 42.01 lacs respectively as compared to the method being followed earlier.

In case of assets whose useful lives have ended, the carrying value, net of residual value as on 1st April, 2014 amounting to Rs. 7.24 lacs has been charged to the Retained Earnings as on 1st April, 2014 pursuant to the provisions of Schedule II to the Companies Act, 2013.

5. Figures for the previous period / year have been re-classified / re-arranged / re-grouped, wherever necessary,to make them comparable.
