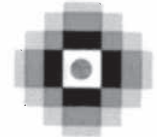

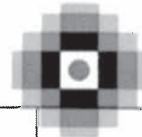

The said pledged shares were held by IL&FS Financial Services Ltd as an agent acting on behalf of ITCL as security for payment of all outstanding dues under the Debentures. Since the Debentures were redeemed, the same equity shares of Gati Ltd were pledged by TCI Finance Ltd with ITCL in its capacity as a Security Trustee for the facility availed by ITAG Business Solutions Limited. Further, equity shares of Gati Ltd were also pledged by Mahendra Kumar Agarwal (HUF) and Dhruv Agarwal Benefit Trust for the facility availed by ITAG Business Solutions Limited at various dates totaling to 12901000 shares

(Disclosure was made by ITCL under Regulation 29(2) of the SEBI on December 26, 2013 for sale of 1950000 Shares as those exceeded 2% of the paid up capital as on that date.)

Out of available balance pledge of 8801000 Shares , 8601000 shares were released on April 15, 2014, Since total 8601000 shares of Gati Limited exceeds 2% of the paid up capital as on April 15, 2014 ,hence the Disclosure as required under Regulation 29(2) of the SEBI (Substantial acquisition of shares and takeovers) regulations, 2011 has been made as aforesaid.
