CHANGE IN AGENDA ITEM NUMBER 3 OF AGM NOTICE PERTAINING TO RE-APPOINTMENT OF DIRECTOR RETIRING BY ROTATION - SUBSTITUTING NAME OF SHRI M M SRIVASTAVA, IAS (RETD.) [DIN: 02190050] IN PLACE OF NAME OF SHRI D J PANDIAN, IAS [DIN: 00015443]:

It is informed to the Members that the Company has received a letter on 6th September, 2014 from Shri D J Pandian, IAS [DIN: 00015443] tendering resignation from the Board of the Company consequent to his transfer from the position of ACS, Energy and Petrochemicals Department, Govt. of Gujarat. In view of cessation of Shri D J Pandian, IAS [DIN: 00015443] as Director of the Company w.e.f. 6th September, 2014, his name cannot be considered as Director liable to retire by rotation at the ensuing AGM.
