**Sub: Corporate Announcement – NSE Symbol : INDIANB – Stock Code : 532814 - Issue of equity shares aggregating to ₹ 280 crore to Government of India on Preferential basis.**

We refer to our letters No.ISC/757/2014-15 dated 09.02.2015 and No.ISC/764/2014-15 dated 14.02.2015, conveying the decision of the Government of India to infuse capital funds to the tune of ₹ 280 crore in our Bank by way of preferential allotment of equity to Government of India and about convening of Extra-ordinary General Meeting (EGM) of the shareholders of the Bank on March 23, 2015, to obtain their approval for the proposed preferential issue.

Further to the above, we now inform as under;

- i) As already informed, the Relevant Date for determining the Issue Price was fixed as February 20, 2015.
- ii) As per Regulation 76 (1) of SEBI (ICDR) Regulations, 2009, the minimum Issue Price has been fixed at ₹ 181.31 per equity share of face value of ₹ 10/- each, including a premium of ₹ 171.31 per share.
- iii) Accordingly, the number of shares to be issued by the Bank to the Government of India on preferential basis will be 1,54,43,163 (One crore fifty four lakhs forty three thousand one hundred and sixty three only).
- iv) Subject to approval of the above Issue by the shareholders of the Bank, the Pre and Post Issue shareholding position will be as under;
