

## Crude Steel production grew 6% in 9M 2014-15

JSW Steel Limited reports quarterly Crude Steel production at 3.17 million tons for Q3 FY 2014-15.

The break-up of production is as below:

The Company achieved cumulative Crude Steel production of 9.57 million tons in the first nine months of FY'15 showing a growth of 6% over the corresponding period of last year.
