Jaiprakash Power Ventures Limited (the "Company") U.S. \$ 200,000,000 5.0 per cent. Convertible Bonds due 2015 (the "Bonds")

The Bonds mature on 13 February 2015. This is to inform you that the Company has entered into a standstill agreement dated 12 February 2015 (the "Standstill Agreement") with certain holders of the Bonds that collectively hold 76.09% per cent. of the aggregate principal amount of the Bonds outstanding as of today. Pursuant to the Standstill Agreement, the standstill period extends until 27 February 2015.

The Standstill Agreement summarises the key terms on which the parties have reached inprinciple agreement in relation to effecting a rescheduling of the Company's redemption obligations in respect of the Bonds (including the extension of the maturity date) and which is to be documented in, inter alia, a further standstill and voting agreement, subject to certain conditions. The terms of the aforementioned rescheduling are subject to receipt of approval of the Reserve Bank of India.
