Note: Please note that the aggregate shareholding of AIF decreased from 3,423,763 equity shares representing 5.32% (based on total number of equity shares of 64,342,906 on 30 September 2010) to 2,052,415 of equity shares representing 3.14% (based on total number of equity shares of 65,426,900 on 31 December 2013) by open market purchase of 100,000 equity shares, and open market sale of 1,471,348 equity shares representing 0.16% and 2.34% of the share capital of the company respectively. 1,471,348 equity shares have been sold in tranches and pursuant to the last tranches of 236,594 equity shares (233,517 + 3,077) sold on 4 April 2014 the aggregate shareholding decreased by more than 2% from the last disclosure made on 12 October 2010.
