3. Approved the Placement Document.

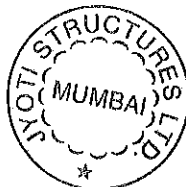

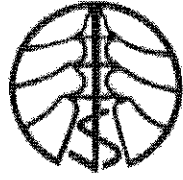

**“RESOLVED THAT** in respect of the issue of equity shares of face value of ₹2 each (**Equity Share**), by the Company through a Qualified Institutions Placement (**Issue**) in terms of Chapter VIII of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2009 as amended, (**SEBI Regulations**), Companies Act, 2013 and the rules made thereunder, and as approved by the shareholders of the Company through a resolution dated August 12, 2014, which opened for subscription on September 24, 2014, be and is hereby declared as closed today with immediate effect.
