The Postal Ballot/ e-voting conducted for obtaining the approval of the public shareholders (other than Promoter and Promoter Group shareholders) for the Scheme, pursuant to SEBI Circulars No. CIR/ CFD / DIL /5 /2013 dated February 4, 2013 and CIR / CFD / DIL / 8/ 2013 dated May 21, 2013, as set out in Postal Ballot notice dated September 22, 2014 under Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014 was concluded on November 6, 2014.

Based on the Scrutinizer's report dated November 10, 2014, the Chairman appointed by the Hon'ble High Court of Judicature at Madras in its order dated September 9, 2014 in Company Application No. 875 of 2014 for the court convened meeting, has on November 12, 2014 declared that the resolution was approved by the public shareholders with **requisite majority**.
