In the winding up Petition No. 1017 of 2002, Company Application No. 231 of 2004, the Hon'ble High Court of Bombay vide order dtd.12th March,2004 has appointed the Special Committee to take charge of the management and affairs of the Company. The Special Committee has been appointed instead of appointment of the Official Liquidator.
2. The above results were reviewed by the Audit Committee and the same was considered and taken on record by the Board at its meeting held on 28th January, 2014 and approved by Special Committee appointed by Hon'ble High Court of Bombay.
3. The Statutory auditors have carried out the limited review of the result for the quarter ended 31st December, 2013.
4. There were no business operations of the Company by virtue of the restrictions imposed by RBI in the year 1998. The income shown above is of miscellaneous in nature.
5. The segmentwise reporting is not applicable.
6. The Hon'ble High Court of Bombay vide its order dated 9th February, 2012 has approved comprehensive Scheme of Repayment to Fixed Deposit Holders. The Scheme does not provide for payment of any interest on any category of Fixed Deposits. However, the Hon'ble High Court of Bombay vide its Order dated 26.11.13 has stopped payment to the creditors of the Company including the deposit holders till 28th April, 2014.
7. The previous period figures have been regrouped and reclassified wherever necessary. The other expenditure includes write off of certain accounts as bad debts. As per the company's practice, the write offs are decided at the end of the year. Hence, the same was not reflected in quarterly results.
8. The Opening Balance of the investor's complaints as at 01.10.13 was NIL - Received during the quarter 16 nos. Resolved during the quarter 16 nos. - Closing Balance as at 31.12.13 is NIL.
9. The Company has no Promoters holding hence the information related to number of shares pledged / encumbered reporting is not applicable.



We conducted our review in accordance with the Standard on Review Engagement (SRE) 2400, *Engagements to Review Financial Statements* issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results prepared in accordance with applicable accounting standards<sup>1</sup> and other recognised accounting practices and policies has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement including the manner in which it is to be disclosed, or that it contains any material misstatement.
