NOTICE is hereby given pursuant to Section 110 of the Companies Act, 2013, read with Rule 22 of the Companies (Management and Administration) Rules, 2014 (including any statutory modification or re-enactment thereof for the time being in force) that the resolutions appended below are proposed to be passed through Postal Ballot for the purpose of 'Change in the situation of registered office outside the local limits but within the same State'.

The Explanatory Statement pursuant to Section 102 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules 2014 in respect of the Item No. 1 is annexed hereto.

The Notice is being sent to all the members by the prescribed mode under the Rules (and also electronically by email to those members who have registered their Email Ids with the Company), whose names appear in the Register of Members / Record of Depositories

(Specified Date) as on July 11, 2014. The members whose names appear in the Register of Members / Record of Depositories as on July 11, 2014 will only be considered for

voting. The Postal Ballot Notice, Postal Ballot Form and the Self - addressed Business Reply envelope is enclosed for the use of the Members.

- Members have the option either to vote through the e-voting process or through the Postal Ballot Form. Members who have received the Postal Ballot Notice by email and who wish to vote through Postal Ballot Form can download Postal Ballot Form from the Company's website www.mahaanfoods.com.

VOTING IN PHYSICAL FORM

As per provisions of Section 12(5) of the Companies Act, 2013, shifting of registered office of a company outside the local limits of any city or town requires approval of shareholders by way of special resolution.
