Happinest signals the foray of Mahindra Lifespaces into the affordable housing space with the objective of enabling a cross section of Indians to fulfil their dreams of home ownership in a safe, secure and healthy environment.

Built on the three pillars of Trust, Better Living and Affordability, Happinest endeavours to meet the housing needs of families with a current combined monthly income of Rs. 20,000/- to Rs. 40,000/-."

Spread over 13 acres, Happinest will be home to 1200+ families. The development consists of 1 and 2 BHK apartments with sizes ranging from 396 sq. ft. to 677 sq. ft.

Units at Happinest have been designed keeping in mind the customer's current needs and future aspirations with provision for appliances like air conditioners and washing machines. The development will have 24X7 power backup for common areas, elevators and plenty of greenery for children and senior citizens. A dedicated Community Activity Area called 'Avadi Court' is aimed at fostering community living within this safe and secure environment. Commercial shops to meet the needs of the residents along with a dedicated auto bay for easy commute to the markets are some of the conveniences incorporated in the project.

Keeping the warm and humid climate in mind, louvres for cross ventilation and CLC (cellular lightweight concrete) block walls that reduce heat, are being used in the development. In line with Mahindra Lifespaces' green philosophy, Happinest will undertake rainwater harvesting, top-soil preservation, use environment-friendly building materials, etc. All of this will result in Happinest, Avadi not only being a low maintenance development but also a Green Building Project that has currently been pre-certified by the IGBC (Indian Green Building Council).



The key to deliver affordable housing is to keep costs low without compromising on quality or speed of execution. This has been made possible in Happinest projects by focusing on innovations and value engineering. The company has not only invested in hybrid technology solutions to enable speed but has also collaborated with IIT Madras for a cost effective and innovative foundation design.
