- (d) 17 equity shares of the face value of INR 10 each (credited as fully paid up) of the Company for every 100 equity shares of the face value of INR 10 each (credited as fully paid-up) held by each shareholder in MIIPL;
- (e) 105 equity shares of the face value of INR 10 each (credited as fully paid up) of the Company for every 100 equity shares of the face value of EUR 1 each (credited as fully paid-up) held by each shareholder in PIA 3.

No fractional shares will be issued by the Company.
