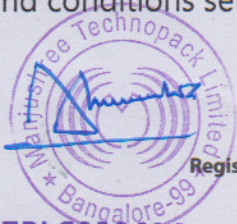

Dear Sir,

1. The Company is in receipt of a letter dated 11th November 2014 ("**Letter Proposal**") from Shruti Financial Services Private Limited and Manjushree Fincap Private Limited ("**Acquirers**") informing us of a proposal to voluntarily delist the equity shares of the Company currently listed on the BSE Limited and the National Stock Exchange of India Limited in accordance with the Securities and Exchange Board of India (Delisting of Equity Shares) Regulations, 2009, as amended from time to time, by offering to purchase all outstanding equity shares of the Company held by the Company's public shareholders (the "**Delisting Proposal**"); and

The Acquirers have granted and agreed to explore the above investment opportunity subject to the terms and conditions set out in the Investment Proposal and any other

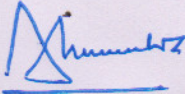
