NOTE:

- The Unaudited financial results have been reviewed by the Audit Committee in their meeting held on July 18, 2014 and approved by the Board of Directors at its meeting held on July 18, 2014.
- Net Sales /Income from Operations includes Product Development Fees straddling innovation, new product development and incubation in water related products - Rs. 187.50 Lakhs for the quarter (corresponding quarter of previous year Rs. 150 Lakhs).
- Other Income for the quarter comprises Interest on Deposits and Profit on Sale of Mutual Fund Units, in respect of the monies lying unutilized out of the Preferential Allotment made in 2007.
- Other Operating Income for the quarter comprises of write back of excess provision of earlier year Rs. 99.54 Lakhs (Previous year corresponding quarter Nil).
- The proceeds of preferential allotment of 2007 have been utilised for the specified objects and the unutilised amount of Rs. 2,530.42 Lakhs as at June 30, 2014 has been invested in Inter Corporate Deposits and units of Mutual Fund.
- Further to the approval of the Board of Directors of the Company at its meeting held on November 12, 2013, the members of the Company at the Court Convened Meeting have with the requisite majority approved the scheme of merger of the Company with Tata Global Beverages Limited in terms of a scheme of amalgamation under Section 391-394 and other applicable provisions of the Companies Act, 1956. The majority of the public shareholders have also approved the said Scheme through the Postal Ballot as required under SEBI Circular dated 4th February, 2013 read with Circular dated 21st May, 2013. The appointed date of the Scheme is April 1, 2013. The Scheme would become effective after receipt of all requisite statutory and other necessary approvals. As per the scheme, the business operations of the Company are being carried out in trust on behalf of TGBL from the appointed date till the effective date.
- As per the requirement of the Companies Act, 2013 and in the manner prescribed in Schedule II of the said Act, based on technical evaluation, the Company has provided depreciation on the useful life of the assets.
- Disclosure of segment-wise information is not applicable, since the Company is engaged only in one segment i.e. Natural Mineral Water.
- The figures of the previous periods/year have been regrouped to conform to the current year.

AUDITOR'S REPORT TO THE BOARD OF DIRECTORS OF MOUNT EVEREST MINERAL WATER LIMITED ON LIMITED REVIEW OF UNAUDITED FINANCIAL RESULTS FOR THE QUARTER ENDED 30th June 2014

We have reviewed the accompanying statement of unaudited financial results of Mount Everest Mineral Water Ltd for the quarter ended 30th June 2014 except for disclosures regarding public shareholding and promoter and promoter group shareholding which have been traced from disclosures made by the management and have not been audited by us. This statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on these financial statements based on our review.

We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410, Engagements to review financial information issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of the company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
