According to a report India lost \$8 bn in 2011 due to cybercrime and is ranked 5th in e-commerce breaches. The Govt of India has also recognized the need for building capability to fight against hackers and as a result also rolled out India's first cyber security policy in 2013. According to a Nasscom report, there are only 22,000 experts in India compared to 2.5 million in China. Forbes ranks Ethical Hacking as no 2 in highest paying jobs of the future.
