synchronizing with hooper against Mumbai. VR Raghunath, Ramandeep Singh with Lloyd Norris-Jones (South Africa) scored in crucial matches. A combination of mixed talent, young and seasoned, Punjab Warriors gained a great deal thanks to the good work put in Sandeep Singh, the top scorer of last two seasons with 11 goals each on both occasions. Five-time FHI player of the year, the gallant Aussie, Jaime Dwyer along with SV Sunil and Affan Yusuf are in splendid shape to write a history for Punjab Warriors.
