International Headquarter Status to Strides Pharma Global Pte. Ltd., Singapore**

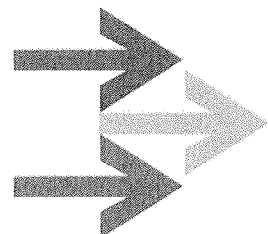
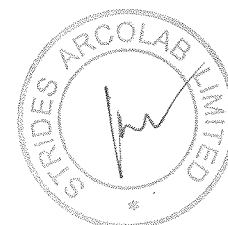
