Suven Life secures One (1) Product Patent in South Korea and one (1) from USA

HYDERABAD, INDIA (October 13, 2014) – Suven Life sciences Ltd (Suven) announces today that its drug discovery portfolio which has expanded into several new therapeutic areas such as Major Depressive Disorder (MDD), Obesity and Pain through Neuronal Nicotinic Receptor modulators resulted in the grant of **one (1) product patent from USA (8735423) and one (1) product patent from South Korea (10-1410903)** corresponding to the New Chemical Entity (NCE) for the treatment of disorders associated with Neurodegenerative diseases and these Patents are valid through 2030

The granted claims of the patents include the class of **selective alpha-4-beta-2 compounds discovered by Suven** and are being developed as therapeutic agents for **major depressive disorder (MDD)**.

With these new patents, Suven has a total of **nineteen (19) granted patents from USA and fifteen (15) granted patents from South Korea**. These granted patents are exclusive intellectual property of Suven and are achieved through the **internal discovery research** efforts. Products out of these inventions may be out-licensed at various phases of clinical development like at Phase-I or Phase-II.
