Suven Life secures Five (5) Product Patents for their NCEs in Australia, Europe, Hong Kong, Israel and Norway

HYDERABAD, INDIA (April 24, 2015) – Suven Life Sciences Ltd (Suven) announces today that the grant of one (1) product patent from Australia (2010340745), one (1) product patent from Europe (2121602), one (1) product patent from Hong Kong (1159626), one (1) product patent from Israel (211747) and one (1) product patent from Norway (335838) corresponding to the New Chemical Entities (NCEs) for the treatment of disorders associated with Neurodegenerative diseases.

The granted claims of the patents include the class of **selective 5-HT compounds discovered by Suven** and are being developed as therapeutic agents and are useful in the treatment of cognitive impairment associated with neurodegenerative disorders like Alzheimer's disease, Attention deficient hyperactivity disorder (ADHD), Huntington's disease, Parkinson and Schizophrenia.

With these new patents, Suven has a total of **twenty one (21) granted patents from Australia, fifteen (15) granted patents from Europe, sixteen (16) product patents from Hong Kong, four (4) product patents from Israel and five (5) product patents from Norway**. These granted patents are exclusive intellectual property of Suven and are achieved through the **internal discovery research** efforts. Products out of these inventions may be out-licensed at various phases of clinical development like at Phase-I or Phase-II.

"We are very pleased by the grant of these patents to Suven for our pipeline of molecules in CNS arena that are being developed for cognitive disorders with high unmet medical need with huge market potential globally" says Venkat Jasti, CEO of Suven.
