- **Best ever annual sales to the Automotive segment at 1.17 million tonnes**, (previous best was 1.05 million tonnes in FY'12).
- **Best ever annual sales in Industrial Products segment at 1.7 million tonnes**, (63% more than the previous best of FY13 at 1.07 million tonnes). This includes the **highest ever Hi-end sales** at 283 kt sales from a level of 165 kt in FY 13.
- **Best ever annual sales in LPG segment at 110 kt** and a market share of 23%. This was 345% better than FY13 sales at 32 kt.
