

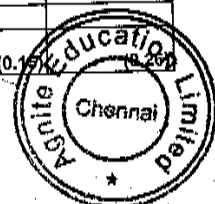

F. Revenue expenditure incurred during the period in connection with e-learning projects will be capitalised during the time of audit.

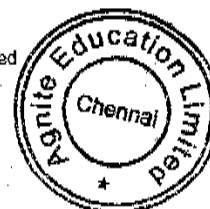

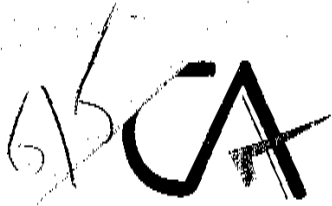

LIMITED REVIEW REPORT

This statement is the responsibility of the company's management and has been approved by the Board of Directors. 
