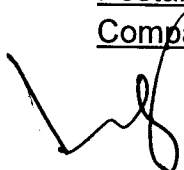

Sub: Report on e-Voting and Postal Ballots of Titan Company Limited vide Notice dated 1st August, 2014

On verification of the 69 Postal Ballots received and voting through e-Voting, up to 13th September, 2014 from the Shareholders of Titan Company Limited, holding Equity Shares, both in physical and electronic mode, and based on the information made available to me, I hereby submit my Report on the results of the Postal Ballots, as follows:

Business proposed in the Postal Ballot vide Special Resolutions as specified in the Postal Ballot Notice dated 1st August, 2014 dispatched to the members of the Company on 13th August, 2014:

- 3) Acceptance of Deposits from Members under Section 73(2) of the Companies Act, 2013.

Following may be kindly taken note of:

1. The list of Shareholders as on 25th July, 2014 was furnished by your Registrar & Share Transfer Agent namely TSR Darashaw Private Limited, Mumbai, ('RTA'). The scrutiny is based on the said list of Shareholders.
2. As regards the Postal Ballots received, checking and tallying of signatures, details of Shareholders including the number of Shares, their client id number/registered folio number were carried out at the office of the RTA. Specimen signatures of the Shareholders were made available to us for this purpose.

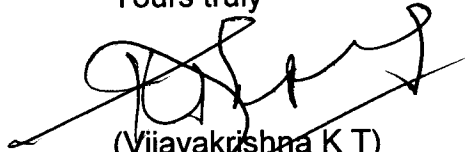
